Privacy Policy

Enguard LLC ("Enguard", "we" and "our") respects your privacy. This policy explains the privacy practices for our website enguard.io (the "Website"), and in connection with the services ("Services") we provide to our customers. It describes the ways your personal information is collected and used and the rights and options available to you with respect to your information.

Providing us your personal information is a choice you make. You are not legally obligated to provide us with this information, but we do need it to provide enhanced user experience on the site.

Your consent serves as the legal basis for processing your personal information. You may withdraw consent at any time, without affecting the lawfulness of data processing we carried out based on your consent before the withdrawal. Personal Information That We Collect

We may use third party analytics and advertising tools, such as Google Analytics, to collect information pertaining to your activities on the Website. This includes the information or content that you opened, viewed or clicked on, your session durations, the web pages you accessed, the Internet Protocol (IP) address through which you accessed the Website and the city or town where the computer you used to access the Website is located. We do not intentionally or knowingly collect personal information regarding children who are under 18 years of age.

Use of Information

We may use the information outlined above for the following purposes:

- To facilitate the access to and use of the Website and its features, and to manage the operational and administrative aspects of the Website;
- If you provided your contact details or submitted an inquiry we may use your information to contact you, either directly or through others on our behalf, including by e-mail messages;

- Take any action in any case of dispute involving you with respect to the Website.
- Send periodic e-mails (information and updates including company news and product developments, reports, invitations, suggestions of interest and other marketing materials).
- Conduct sales and service related communications (personal e-mails and phone calls, event invitations etc.). To develop and improve our products and services as a whole, and to improve and enhance the services and content offered on the Website;
- To enforce this policy, and prevent misuse of the Website and our Services;
- Take any action in any case of dispute involving you with respect to the Website or the Services.
- To fulfill the purpose for which you provide it, for any other purpose disclosed by us when you provide the information, or otherwise with your consent.

Sharing Information With Third Parties

We may share personal information outlined in this policy, with others, in any of the following instances:

- If you abused your rights to use the Website, or violated any applicable law your information may be shared with authorities or other third parties, if we believe it is necessary or justified;
- With attorneys, courts, government agencies and relevant third parties, in any case of dispute, or legal proceeding of any kind involving you with respect to the Website or the Services;
- With our service providers, in order provide the Services, to operate, maintain and enhance the Website and facilitate our email communications with you;

In any case other than above, your personal information will be shared with others only if you provide your explicit prior consent.

Aggregated or Anonymized Information

We may use the information we collect, as outlined above, to compile anonymized or aggregated information, either by ourselves or with the assistance of third parties. We may share, sell or otherwise communicate and make available such anonymized or aggregated information to any other third party, at our sole discretion.

Cookies and Other Trackers

We use various types of cookies and other types of web trackers, which help us to administer and operate the Website and improve our ability to deliver content and ads that are more relevant to you.

These trackers are used for the following main purposes:

- Collect statistical information about your use of the Website;

- Collect behavioral information about your surfing on our own Website and other websites which then helps advertisers like us deliver ads that are more relevant to you.

We use cookies for Website analytics purposes, as explained above in the section titled "Personal information that we collect".

We also use cookies to deliver to you more relevant ads for our products and services as you surf the web (this is known as "retargeting"). These cookies originate from Google.

Accessing, Updating or Deleting Your Information

You may ask to access the personal information about you that is stored in our systems, or have us update, correct or delete such information. You are also entitled to ask to transfer your data to another party ('data portability' right), in accordance with the law. Data Retention

We retain personally identifiable information for as long as we deem necessary for the purposes set forth above. We may delete information from our systems, without notice to you, once we deem it is no longer necessary for the purposes set forth above.

Data Security

We implement measures to reduce risks of damage, loss and unauthorized access or use of information, but they do not provide absolute security. Therefore, we cannot guarantee that the

Website is immune to unauthorized access to the information stored therein and to other information security risks.

California Residents

The following disclosure is made pursuant to California Online Privacy Protection Act: When you use our Website, other parties, may collect personally identifiable information about your activities over time and across different websites or online services. We do not support Do Not Track. Do Not Track is a preference you can set in your web browser to inform websites that you do not want to be tracked. You can enable or disable Do Not Track by visiting the Preferences or Settings page of your web browser.

Changes to This Privacy Policy

We may change this policy from time to time. Substantial changes will take effect 30 days after we provide a notice of such changes on the Website. Other changes will take effect 7 days after we provide notice. However, if the policy is amended to comply with legal requirements, the amendments will become effective immediately upon their initial posting, or as required. In any event, we will seek your explicit consent if we wish to have substantial changes to the policy apply to personal information we collected prior to those changes.
